



**OFFICE MEMORANDUM**

**Sub:- Empanelment/Engagement of Teachers & FCSA on contract basis in JNVs Under Pune Region for the session 2017-18 - reg.**

With regards to this office Circular No. 2-58/NVS(PR)/2017-18/700 dated 30.05.2017, some of the Principals have sought clarification regarding educational qualification of the Faculty-Cum-System-Administrator (FCSA) particularly for those candidates who have done B.Sc. (Computer Science). In this connection it is clarified that the candidates who produced equivalency certificate from their university to the effect that the B.Sc. (Computer Science) done by them is equivalent to B.C.A., such candidates may be considered for the post of FCSA on production of equivalency certificate from the concerned university. The last date for submission of application together with equivalency certificate **is extended up to 30.06.2017 for the post of FCSA ONLY.**

Further the following schedule may be adopted for the contract appointment of FCSA.

- i) Date of scrutiny, allotment of marks by the recruitment committee and uploading the merit list in the website of vidyalaya - **04.07.2017.**
- ii) Verification of original certificates by the committee - **06.07.2017.** and issue of offer of appointment.
- iii) Signing of contract agreement and appointment of the candidates- **07.07.2017.**
- iv) Dispatch of merit list of remaining candidates to the Cluster co-coordinator for preparation of fresh Reserve Panel - **10.07.2017.**
- v) The eligible candidate may be informed by **E-MAIL/TELEPHONIC MESSAGE** to appear in person for verification of certificates/testimonial etc. on **06.07.2017.**
- vi) A copy of corrigendum is enclosed herewith which may be uploaded in JNVs website also.

### CORRIGENDUM

#### **Sub:- CONTRACT APPOINTMENT OF TEACHERS IN JAWAHAR NAVODAYA VIDYALYAS- REG.**

Further, the date of submission of application together with testimonials and equivalency certificate is **extended up to 30.06.2017**. In case of the candidate who has already applied for the post of FCSA having B.Sc. (Computer Science) degree may submit equivalency certificate **up to 30.06.2017**, failing which their candidature shall not be considered for the post of FCSA in Jawahar Navodaya Vidyalayas on contract basis.
